1. Director's Report -

- a. ARPA There are two ARPA statewide grants for public libraries:
 - The MI-83 TLC Kits program has been announced. All that is required of you is to complete the request online by **December 13**th and ask for the equipment you are interested in receiving. If you receive a computing device (laptop or Chromebook), you will need to comply with CIPA and filter. There are kits for creating virtual programming, and for outside programs as well. All requests will be granted unless the total exceeds available funding, in which case the poverty and unemployment measures will be applied to prioritize need.
 - 2) The MI-83 DLC Content program will be announced by OverDrive consortium, beginning with the standalone systems, followed by the shared content groups like ours (Up North Digital). Libraries will receive information about the amount of content credit they will have to use to purchase one copy/one user titles from curated lists on the non-fiction topics covered by the grant (education, health, job-seeking skills, and workforce development), and will have the option to give the credit to the consortium or to keep it for their local Advantage account. Stay tuned for more information.
- b. Emergency Connectivity Fund program Our ECF application for 25 of our members has been funded. Sheryl is working with Janelle Morgan of Elite Fund on ordering and making sure the fund is reimbursing properly. Please read the information on our website about ECF (under grants: https://www.mmll.org/a/grants). More resources will be coming for those libraries getting equipment to check out to patrons (computing devices and hotspots), such as a sample sign-out sheet and example procedures.
