

2021 Association for Rural & Small Libraries (ARSL) Conference Cora Schaeff, 10/31/2021

"Be brave. Be curious. Be kind. Be mindful. Show up. Have the tough conversations and be open to change" - Kathy Zappitello, Board President, The Association for Rural & Small Libraries and Executive Director, Conneaut Public Library. OH

I was recently able to attend my first ARSL Annual Conference in Reno, Nevada, where I spent four days renewing my professional confidence and motivation and immersing myself in learning. Attendance at this conference was made possible by the support of a Continuing Education Stipend from the Library of Michigan.

The option to attend a pre-conference workshop, *Library Space: A Planning Resource for Librarians*, was an obvious yes for me. Even though our doors were closed due to the pandemic, patrons began inquiring about a renovation to our library space from the first day I arrived as director. Renovate the existing library or build new? That is the question, and I have acquired more knowledge and resources to assist in the answer - **CONFIDENCE**.

I did become emotional when I arrived at the banquet hall the following morning for the kickoff keynote and meal. Although the organizers had decided that proof of vaccination was required for attendance and the State of Nevada is still requiring masks indoors, I was nervous. This was the largest gathering that I have attended since the pandemic. Nervous, but also excited! Networking is one of the main reasons that I attend these events, so I was very excited to meet new people, catch up with colleagues, and learn about the amazing opportunities that rural and small libraries are creating for their communities.

The keynote began by talking about marginalized and oppressed humans, which is not really a recipe for an uplifting tone. But what is a more important topic for library professionals right now? The entire conference was framed in justice, equity, and inclusion, and each breakout session and the other keynotes

that followed embraced this path. Authors Michael Branch and Qian Julie Wang brought us closer as humans instead of dividing us by the fears we perceive. Both of these authors shared the importance of libraries, and more importantly library staff, in their lives - MOTIVATION.

We were fortunate to view the world premiere of the Latinx Photography Project, a documentary film directed and produced by Alejandro Palacios. While watching the film, I decided that working collaboratively with the other libraries in our county to stream the film, interview the director, and open conversation about our migrant population in Leelanau County, may serve our library patrons well. Opportunities such as these are so important to the overall quality of life for our citizens, and I am hopeful that we will be able to offer this program.

During the four days that I was in attendance, I was busy unpacking racial and class biases, learning how to pitch the library, turning storytime into skills-building time, learning how to affect positive change in the library and community, making data-informed decisions, learning how to teach leadership through young adult literature and that graphic novels are "real" books (this one I knew :0), gaining expert knowledge, along with building support for the library - LEARNING.

The conference was rounded out with the State of ARSL presentation that highlighted the work going on behind the scenes in the ARSL office and the announcement that ARSL will be held in Chattanooga, Tennessee next September. If you are a library professional in a rural and small library, I encourage you to become a member of ARSL and make it a priority to continue to educate and connect with other libraries to benefit your community.

Challenges to library materials based on subject matter or content are increasing throughout the country. According to the ALA Office of Intellectual Freedom, requests for assistance by libraries experiencing a challenge have increased 60% in the last year.

The best way a library can prepare for a materials challenge is to implement a clear, straightforward policy and procedure for handling materials challenges and censorship.
