

#### **Bid Window**

Minimum 28 Days Longer is OK



#### **Evaluate Bids**

Price **MUST** be the primary factor

  - Services
- Discount Calculations






### Billed Entity Applicant Reimbursement (BEAR) Billing

## Audit Prep: What to keep

- All FCC forms and documents and correspondence related to...
  - Filing Process
  - Competitive Bidding Process
  - Program Integrity Assurance (PIA)
  - Service delivery and maintenance of related service and equipment
  - Billing, Invoicing, and Payments
  - CIPA Compliance
  - Change Requests and Appeals

Keep these records a minimum of 10 years past the last day of service\*






## Michigan State Education Network (MiSEN)

#### State of Michigan E-Rate Enhancement Special Construction Matching Fund

The Michigan Department of Education (MDE) is pleased to announce the allocation of \$5 million for the purposes of leveraging additional dollars through the federal E-Rate program for special construction builds upgrading district, intermediate school district (ISD), public school academy (PSA), and library broadband connections. Using these funds, eligible applicants and consortia groups could leverage up to an additional 10% in E-Rate discount award with a dollar-for-dollar match in state funding on approved special construction builds. As a reminder, the extra discount and state dollars would only be applied to the one-time special construction related charges associated with the application, including:

- Design
- Engineering
- Project Management
- Digging Trenches
- Laying Fiber

### Special Construction Matching Fund Grant

- 16 Applications from 15 Applicants
- 13 USAC approved applications
  - Over \$293k awarded
- Two applications still pending with USAC

E-Rate Funding Year 2020 Matching Grant Process\*

#### **PROCUREMENT:**

File 470 soliciting bids from providers

#### **APPLY:**

Applicant completes application for Matching Fund grant

#### **PRE-APPROVAL:**

"Award not to exceed..." "Contingent upon project approval..." **CERTIFY**:

Applicant certifies Form 471 for discounted service

#### **USAC APPROVAL:**

Applicant survives PIA review and receives FCDL from USAC

#### PROJECT COMPLETION:

Contracted vendor completes and "lights" connection

#### **PROOF:**

Applicant provides proof of completion

#### **PAYMENT:**

Applicant receives payment through CMS
