Mid-Michigan Library League Director's Report

August 2017

Administrative:

- Every expenditure made from the MMLL budget has been reviewed and many have been discontinued or reduced in order to maximize the ability to serve the membership. The budgets that have been proposed all reflect these savings and the cooperative office running on very minimal funds/overhead.
- In FY18, beginning October 1, 2017, the Mid-Michigan Library League will have 36 members. Two libraries, Suttons Bay Bingham District Library and Houghton Lake Public Library, had given us resolutions signed by their Boards to leave MMLL in order to join other cooperatives. Ardis Missaukee District Library will not qualify for State Aid in FY18 and their Board has selected not to pay for cooperative membership. Because of the reduction in membership, we also have a reduction in revenues for the cooperative.
- The Finance Committee and Advisory Council Co-Chairs met on July 27th at the Mason County District Library in Ludington. The group reviewed five separate budget scenarios for FY18 along with revised Plan of Service and MMLL Benefits of Membership drafts. The group considered staffing level options along with the choice of a virtual vs. physical cooperative office. Going forward, the Finance Committee will recommend the budget and associated document revisions most favored by the group. The recommendation will include remaining in the current office location, staying at the current staffing levels (director full time, bookkeeper 10 hrs.), freeing up \$15,000 for e-resources to serve the entire cooperative without billing the membership, keeping the mini-grant program, and providing a bank of four hours of tech support for each member, to be fulfilled by a third party contractor.

Interlibrary loan:

MMLL members who wish to participate in the White Pine Library Cooperative OCLC interlibrary loan system will need to sign an agreement directly with them for the use of their Peabody system. Many of you have already done this. MMLL will no longer cover the cost of the requests made for materials not found on MeLCat, but we have verified this agreement with our colleagues at WPLC and they will be glad to bill you directly on a quarterly basis.  - Missaukee \$610 Lego purchase for Teen Tech Lego Quests
 - o Pathfinder \$250 author program
 - o Richfield \$250 SRC program
 - Walton Erickson \$1,000 purchase computers, scanner, barcodes for MeLCat prep and automation
