- Health insurance After putting all the quotes for policies side-by-side, we selected one for the MMLL director (small group of one). The offerings were limited and very expensive, and as it turns out, the selected policy does not cover a basic recurring need, so Weadock and Associates will be providing more options and we may change the coverage, but premiums will not be higher than the plan selected that began December 1st.
- The Old City Hall (OCH) building, in which we are renting our current office space, has been purchased by Robb Munger, an investor who has been buying other properties in downtown Cadillac. He intends to refurbish, build and develop in the area, and this is a good thing for our building. The rent and common area maintenance (CAM) payments we have been making will be averaged out for the year, so payments will be a consistent amount. This makes budgeting easier, as the CAM payments were up and down depending on the month. Mr. Munger will be making many welcome improvements to the building.
- About half of the membership is either in process or finished with their annual report for State Aid, but I will be reminding the others, as they are due February 1st.

Up North Digital:

- There is now a Steering Committee for the Up North Digital Overdrive consortium comprised of two members from Northland Library Cooperative (Maureen Derenzy – Otsego and Val Meyerson – Petoskey) and two members from Mid-Michigan Library League (Stacy Pasche – Benzie Shores and Eric Smith – Mason Co). Roger Mendel (Northland director) and I are ex-officio members and charged with communications.
- The group is working hard to clarify various issues with the vendor and improve the service. So
 far, the group has been able to get the website (https://upnorth.overdrive.com/) updated to the
 new platform that provides more features, and is working on holds management to reduce the
 long waits for materials.
- Work in process includes refining the internal member understandings/agreements, and creating a
 policy/procedure document on collection development. Once this work is complete, other libraries
 from each cooperative will be given information on how to join, if they so desire.
