Director's Report

May 2016

Administrative:

- A comparison spreadsheet between three prospective office lease situations was put before the Board for consideration. The office on the third floor of the Old City Hall, 201 N. Mitchell St., Suite 302 was the best fit for our needs. A special meeting of the Board was called for Thursday, May 12th to make a formal decision and approval of costs associated with moving. With any luck, we will be moved by the beginning of June.
- State Aid payments have been going out to member libraries. We bill members as we are aware they have received payment.
- Member libraries have signed up for their RIDES service for another MCLS fiscal year. We pay for RIDES for all members and since the MCLS fiscal year is July–June, we divide the costs over the twelve months of future payment so that 9 months of the old contract and 3 months of the new contract are logged as payments for our fiscal year 2016. The FY17 budget will contain the additional 9 months of the new contract.
- RIDES – since we no longer will have a class VI library, but we have two class V libraries, I suggest we pay for branch delivery for the two class V members in the League – Cadillac and Mason County. I recommend Cadillac have 2-day delivery for Mesick and 3-day delivery for Manton; and Mason County have 3-day delivery for Scottville. The cost would be \$5,661 and we are saving \$16,455 for the portion of the RIDES bill for the six libraries leaving the cooperative as of October 1st. We would have been paying \$21,940 if the six libraries were to remain in MMLL.

Trainings:

- The Human Resources Basics, part II: The “Soft Skills” (and some hard ones too) was held at the Cadillac Wexford Public Library on March 31st. We had 18 attendees, 5 of whom came from outside our cooperative.
- There was a Book Repair Basics workshop held in Cadillac on April 28th. It was free and offered by KAPCO. There were 21 attendees.
- There is now a Continuing Education Committee for the cooperative: Kimberly Young (Houghton Lake), Cathy Carter (Benzie Shores), Ryan Deery (Suttons Bay), Michelle Moore (Missaukee), and Eric Smith (Mason County). Since Michelle is moving, we could have another member assigned to this committee. So far, we have tried to collaborate with other cooperatives to bring in a speaker, but they were not ready to do this until about a year from now. But, the Cooperative Director's Association intends to participate in collaborative efforts at continuing education, such as hiring a speaker to do the same program in several locations in order to share the opportunities more broadly. Other efforts will include providing interesting content during the afternoon of scheduled Advisory Council/Board meetings, and trying out a webinar-based bimonthly tech talk. Stay tuned ;-)

 - Walkerville Public/School Library – un-automated; submitted application; not yet scheduled

- The MeLCat participation form does not obligate the library, it serves as a planning tool for MCLS in their implementation scheduling and is an agreement that IF you join, you will follow the rules and procedures created by the representative committees. New Initiatives:

- Mini-Grant Program – The Ad Hoc group, Heather Bassett (Reed City), Bradley Chaplin (Kalkaska), Kim Frazho (Houghton Lake), and Eric Smith (Mason County/Ludington) developed guidelines for the first successful round of the “Library Service Expansion & Mini-Grant Program” which was approved at the November MMLL Board meeting.
 - The Board approved a second round to be run at their March meeting
 - The second round applications are due by June 3rd.

- The kits and printers are pre-reserved for the two maker programs, run by the U-M School of Information via an IMLS grant, that were selected to receive the programming. Houghton Lake Public Library will have the event Wednesday, June 15th – Friday, June 17th and Benzonia Public Library will have the event Tuesday, August 16th – Thursday, August 18th. All are invited to attend.

Cooperative Services:

- The MMLL Board has a committee on representation that held a special meeting on Thursday, May 12th to begin discussions about how to re-carve out the cooperative area into representative groupings for Board representation. They will also look at the services in the Plan of Service and propose edits for a full membership vote this summer.
