Mid-Michigan Library League Director's Report

May 2017

Administrative:

- The Finance Committee asked for strategic planning to inform the new Plan of Service and budget for FY18. The Board decided to have the director send a survey to the membership asking them to prioritize services from the cooperative. A compilation of this survey will be presented at the May 18th Board and Advisory Council meetings. The Board will then decide how to develop a draft Plan of Service and FY18 budget ready for first review at the August 17th meeting.

Automation and MeLCat:

Of the 39 Mid-Michigan Library League member libraries, 35 are automated, 4 have no automated system (ILS) in place. Two of the four that have no ILS have applied to join MeLCat, which will help them to automate, since after they add their collection to MeLCat, they can get a copy of the records to use for local automation. Of the 39 MMLL member libraries, 32 are participating MeLCat members. I have been in touch with staff at MCLS who implement new members, and they will extend an invitation for implementation in the next round to these libraries that have applied to join: Luther, Leroy, Richfield, Walton Erickson, and Walkerville. Chase and Wheatland have not yet submitted a MeLCat application.

Interlibrary loan:

Conversion of the interlibrary loan process is now complete. We changed the Plan of Service two years ago to reflect that the cooperative would no longer be doing interlibrary loan, as MeLCat serves this role. For those materials not found via MeLCat, we have a contract with White Pine Library Co-op to request materials via OCLC. Information went out to the membership and the changeover has gone well. Members have become familiar with the "Peabody" system used for sending OCLC interloan requests to White Pine Library Cooperative. Training materials are online at http://mmll.org/ill.html.

Initiatives:

- Library Service and Technology Act (LSTA) Grant our grant proposal for a three-year project costing \$450,000 was not selected for funding. The title of the grant was "Digital Inclusion on the Go" and the files comprising the grant are posted on the Board page of our website (http://mmll.org/board.html) if you are interested. Dearborn Public Library, Jackson District Library, Wayne State University Libraries and Ypsilanti District Library have all been granted funds for collaborative projects working with underserved populations. You can find a description of the grant funded programs here. It is a bit sad that no upstate or rural areas were selected, however these projects will surely serve their communities well.
- Due to the overwhelming response to National Library Legislative Day this year, we were blocked from registering any more than one person to attend. She is from Ludington and will serve as the only person from the 2nd congressional district, represented by Bill Huizenga.
- Mini Grant Program this year's program has been announced. Applications may be submitted through June 5, 2017. The materials are posted on the website at http://mmll.org/grants.html. We have \$5,000 to give away, from small \$500 grants for continuing education support, to larger awards for projects improving library service.
- The 18 maker kits and two 3D printers have circulated 72 times since we created the collection last year. These materials are for the member libraries to use for programming and demonstrations. This summer will be round 2 of the UMSI Maker Trainings, with programs in Houghton Lake August 15-17 and in Benzonia August 22-24.
