- From the Plan of Service regarding the Board:
 - "Term of Office The term of office shall be three years. The term shall run from October 1 through September 30, or until the annual meeting at which a change in Board officers is made...The officers of the Board shall be Chair, Vice-Chair, Secretary and Treasurer, to be selected for a term of one year or until successors are elected... All officers shall be elected by the MMLL Board members at the **November meeting**, to serve for a term of one year, and shall assume office immediately. No member shall hold the same office more than twice in succession. Should an officer resign before their term has expired, the Chair shall appoint another member of the Board to assume the office for the remainder of the year. If a vacancy occurs in the office of Chair, the Vice-Chair shall succeed to the office. Should a member of the MMLL Board resign or be unable to serve, the libraries which elected the member shall be notified and requested to elect another person to fill out the unexpired term."
- Health insurance The ability to obtain health insurance via Michigan Library Association membership via a partnership with National Insurance Services has been delayed. The plans have yet to be announced and will not begin until February 2018. We will continue to monitor this and share with the membership. For the MMLL director's health insurance, we needed to change from Priority Health, since there is no option for a group of one. We have selected a BCBSM plan that begins December 1, 2017. If there is a favorable difference in what we see from MLA/NIS, we will consider a mid-year change.
- In FY18, beginning October 1, 2017, the Mid-Michigan Library League will have 36 members. Suttons Bay Bingham District Library and Houghton Lake Public Library are going to other library cooperatives, and the Ardis Missaukee District Library will not qualify for State Aid in FY18 and their Board has selected not to pay for cooperative membership.
- The application for state aid FY18 has been locked and submitted, and fidelity bond sent in to the Library of Michigan. The first direct state aid payment to the cooperative will be issued soon.

Trainings:

- FY18 webinars include the Opioid Crisis (now archived), Broadband for public libraries, Basic Erate information for public libraries, and the Digital Public Library of America (DPLA). Watch the website and email for dates and registration information http://mmll.org/workshops.html.

New Services:

- Now that the fiscal year has begun, all areas served by member libraries now have access to about 7,000 downloadable audiobooks from RBdigital, with no limits on simultaneous use or renewals (i.e. no holds necessary). We have also been able to add Transparent Language for the entire area as well. These resources, plus four hours of tech support for each member paid for by the cooperative, are new benefits of membership.
